WHAT TO BRING:

Picture ID for primary and secondary taxpayer, all forms W2/1099 or other income, original or copy of social security cards for everyone on the return, 1098 education forms, 1095- A Market place health insurance forms, information for all deductions/ credits including childcare costs with the provider's tax ID number, and a copy of last year's return (if available). If you are unsure, bring it along. When dropping off a return three forms must be completed. A volunteer will check your paperwork and scan your documents.
